5. Eric Kube, Habitat for Humanity;

They are hoping to bring more activity to area & have taken occupancy on July 1st in old Country Store. One is in Hayward & St Croix Falls. Don't sell bedding or clothing but sell about anything else for a house. Two full time & two part time employees. Last year they had \$700,000 in revenues & \$170,000 in profits at St Croix Falls store. Organization tries to re-invest in town & help people stay in their homes by painting etc. Thompson asked if local Spooner residents will see their help & Kube replied everyone will see a lot of things happening soon. Simple coat of paint can help many houses. At this point, habitat for humanity is asking surrounding communities for donations. Mostly asking for vacant land that may be currently off tax roll. They build & get a family in to get it back on tax roll. Each store is autonomous; Hayward's store serves that area & their funds stay there; Spooner store funds stay here. They give loans to low income but don't charge interest.

Mayor welcomed them to Spooner & encouraged their involvement with community.

b) Chief's Report - incidents during June, 2013;

Increase in traffic. Officer Pank is on leave with a new son. Officers Peterson, Richey & Richter participated in a Special Olympics run. They carried a torch to south side of town to be then taken to Shell Lake. There has been a steady increase in OWI arrests. Officer Quinton & Chief Andrea were involved in a DEC case which stands for Drug & Endangered Child. They found a small child running around in just a diaper. Methamphetamines were involved; it was a very bad situation.

Number of complaints of vandalism in down town area. China House had a burglary. 1,038 calls so far.

c) BID Report;

Vandalism was ripping flowers out & tossing them around into doorways of downtown area. Makes no sense. Cameras may deter behavior. Everroad noted that all buildings on Walnut Street are now occupied.

d) NWRPC Liaison Report;

Dohm talked about meeting he recently attended. Budget is down. There is a new business in Northwest Regional Planning incubator building that makes truck toppers. They are using 20,000 sq foot & have 25
