8. **DISCUSSION/ACTION ITEMS**:

a) 2015 2016 Budget;

Motion (Dunn/Stelter) to approve 2016 budget. PASSED.

b) Paving proposal from Wesleyan church for 3rd St south of Grant St;

Marx – at Municipal Operations there was discussion of Wesleyan Church wanting to pave their parking lot & access road between the lot & Grant St. The blacktop will be at no cost to city. A Church member has concern that if city council changes, they could be denied use of access road. Kohler suggested developing an easement between 2 parties. Motion (Gabriel/Ortmann) to develop an easement for Second Street driveway south of Grant St. PASSED.

c) Wine Walks;

Coquillette – State will allow a non-for-profit to apply for a wine license, 2 times per year for up to 20 participating locations. There are restrictions that need to be followed. Kohler – do we want to create an ordinance? The city already has adopted the State ordinance. Council consensus is to incorporate the wine walks into our ordinance for clarification.

d) Strategic Solar Proposal from AEP;

Marx – rec'd a letter of intent to review a solar proposal, along with financial model projection. The project could save us over long term, but may cost more upfront. System would be a behind meter installation, so we would not pay for capacity & transmission & would allow us to buy energy, from market, at a lower rate. It's feasible, at this time, for AEP because of tax credit that are available & this would lock us in with AEP for 25 yrs with solar. Dunn – has received positive feedback from community. Marx - not in a position to make a recommend today. Council consensus is to hold a Committee of Whole mtg on Nov 17 at 5:00 p.m.

e) Emergency Sprinkler System repair City Hall;

Marx – our insurance company required that our emergency sprinkler system be inspected. JF Ahern did inspection & found 2 items that need to be repaired at a cost of \$1860.00. Also, discussed an annual inspection contract with them. **Motion (Reiter/Coquillette) to approve the sprinkler system repairs of \$1860.00.** PASSED.

f) Spark Grant;

Reiter – there were over 70 applicants & we did not win. Did receive a thank you & encouraged to apply, again, next year.

g) MOU between City and WPPA re:12 hr shift;

Marx – our labor attorney and union representative recommend we pass contract as presented. **Motion** (Dunn/Dohm) to accept the MOU 12 hour shift. Dunn questioned the shift hours & differential. <u>PASSED.</u>

h) Ranking of Part time Police Officer Candidates;

Gabriel – interviewed 5 candidates, all were very good. Christman - did contact candidates & they all accepted to be on roster. **Motion (Ortmann/Dohm) to accept part time officers as ranked. PASSED.**

a) Financial Report Sep 2015;

Motion (Schluter/Dohm) to accept Sep 15 financial as printed. PASSED.

- b) Chief's Report incidents during Oct 2015;
 - Old squad was sold at auction for over \$9500. Our 1st Annual SPD Halloween Haunted House was a success. We collected 772 lbs. of non-perishable food & \$328.00 in cash for Washburn County Food Pantry. Spooner Family Restaurant will be donating proceeds from their Nov 9 sales to Christmas for Kids Program. Officers will assist on this date. Officers attended department meeting & pistol shoot on Oct 27th. SPD assisted with a vehicle pursuit & successfully deploy stop sticks to end same. We were dispatched to Bank Mutual for a person attempting to use fraudulent credit cards. Officers continue to investigate drug & mental health cases. Total incidents for Oct 937.
- c) BID Report;
 - Dunn group that decorates Centennial Park will not be doing it this year. BID will be purchasing some lights.
- d) NWRPC Liaison Report;
 - Dohm working on budgets. Some new business kindling out there.
- e) Library Liaison Report
 - Reiter director search is going well. Have received several applications from good candidates. New children's librarian, Angela, is working out well. Thanks to police department, library was able to retrieve several hundreds of dollars of DVD's when persons of interest caved.
