PROMPT PAYMENT OF BILLS

A charge of 1.0% per month shall be applied to the total unpaid balance, including any unpaid payment charges. This charge will be added to bills not paid within 20 days from the date of issuance.

LARGE POWER TIME-OF-DAY SERVICE (Cp-2)

Availability: This rate is mandatory for all power customers with monthly measured demand exceeding 200 KW for any three of the latest twelve months. Customers billed on this rate will remain on this rate unless their demand is less than 200 KW for less than three months in a 12 month period may choose to be billed on this rate, with the understanding that it would be for a minimum of one year.
