- 2) ROLL CALL; 8 present; 0 absent
- 3) PLEDGE OF ALLEGIANCE;
- 4) PUBLIC COMMENTARY;

Lien asked to have Item i pulled from consent agenda.

5) Mayor's Comments;

Spooner Block Party was reportedly well attended and was good time with no problems. A lot of work was put in by their committee for this event. Rodeo will take place this week with parade having an alternate .5 mile route this year on Roundhouse Road from Rustic Lane to Paulson Drive.

6) Approval of Agenda;

Motion (Ortmann/Parker) to approve consent agenda, discuss g, h, k and remove i. PASSED.

Lien was not at previous mtg for discussion and asks that until further legal clarification can be sought in regards to question of liability and state law as it relates to ownership or control of premises and serving alcohol in this setting that no action be taken. Right of Way permits are issued in some municipalities; City does not have an ordinance for clear guidance on this request. Lien wishes to withdraw this application and work with the city's attorney and administration to obtain solid information. No action taken.

  - Ortmann requested further clarification. Reiter explained history of issues at property and lack of response from owner with city correspondence. No further options seem to be available at this point and raze order is appropriate. Kohler suggests preparing order and allowing an amount of time that gives owner a set timeline to repair property before city tears it down.
  - Motion (Donovan/Parker) to approve City serving raze order notification to property owner at 708 S Front St. Motion amended (Coquillette/Donovan) to have raze order notification delivered by Chief of Police to include 60 days given to homeowner for response. Ayes 7, Nay Ortmann. <u>PASSED</u>.

  - a) Financial Report May 2022;

Motion (Reiter/Gagnon) to approve Financial Report May 2022 as presented. PASSED.

b) Chief's Report;

Chief Christman reported his department has been working with school district reviewing school safety plans and security. River St between north of 63/70 and Walnut has re-opened. Walnut is back to normal traffic flow and parking. Spooner Police Foundation plans to sell raffle tickets during rodeo. Department meetings have discussed summer events, i.e. Block Party, Rodeo, etc., to get new officers acquainted with logistics. Numerous parking tickets issued with one-side parking downtown. A number of traffic crashes were responded to, but none were related to detour. Officers showed presence at school district end of school year. Officers have been at local trainings. Met with UW police in regards to thefts at Ag. Station. Large number of traffic stops, assisted Burnett County with burglary, and issued chicken ordinance violation.

c) BID Report;

Dunn is happy Walnut St is now open and River St is very beautiful. Compliments to Olson and his street department with their help with signage and help keeping things open. Last weekend downtown was very busy with customers and heavy traffic in stores. Certain businesses are perhaps having harder time than others. St project continues to be well ahead of schedule.

d) Railroad Park Update;

Reiter enjoyed having the mayor at their committee meeting at park. Jack Pine Savage Days will be held at park in Aug. Thompson bench has been moved into restful spot where you can sit and see view of downtown. North 40 Steel is working on honor brick steel structure in which bricks can be put in and taken out. All honor bricks are done and will be installed as people donate. Walkway is working out nicely and finishes off the area. 2<sup>nd</sup> garden is growing well and historic signs will be going up soon.

e) Library Liaison Report;

Gagnon reports bookmobile shelving and racks have been ordered for van's interior and exterior will soon be ready for wrapping. Received \$15k grant from historical society and 1st task will be to take oral history from local veterans. Garden plants are healthy. Carnival was attended by 200+ people and Petting Zoo comes tomorrow. Rodeo queen and princess will be at library with horses. Ukester Brown will be performing at Ukulele Festival. Food security is issue in our area and library programs such as Books & Bread and Compassion Kitchen participation numbers indicate there is need for these types of services. Circulation is up from 2021.
