No restitution ordered being the crew was able to fix where subject crossed. Parade was well attended on Roundhouse Rd. Chief discussed specific detail and types of activity that officers have responded to over past month. 169 cases, 958 contacts, 1,127 total.

d) Railroad Park Update;

Reiter – weekend was disappointing with vandalism at park. Police were called. Lynn's Honeywagon was going to pull portable toilets, but they have decided to keep toilets there for now. Cameras are being discussed. Area is looking very nice. Roundtable control shack was installed today. Wall will be going up soon. Possibly looking at adding additional lighting for preventing vandalism.

e) Library Liaison Report;

Gagnon – update on bookmobile, waiting for wrap to be completed and will install shelving. Bookmobile policy is being created. Rough estimate for cost to run bookmobile, \$273 per month, will be dependent on many factors. Board passed resolution that certain bills can be paid without prior authorization. Recurring monthly bills can be paid in advance, but board will authorize at board meeting. Danielle Danford has become newest board member. We were one of 4 libraries that were awarded humanities program. 1 yr contract, Emilie Riewestahl has been hired and she is putting together a program. She also spent time at fair collecting oral history from veterans. As of Aug 1st, there is new streaming service provided at library called Hoopla. It is free with library card. You can read, listen, and watch various programs. July summer program had an extremely high participation and continues to grow. Snakes alive and petting zoo were very popular. Aug is looking to be another heavy activity month with 19 separate activities planned. Circulation for June 22 up a few thousand over May, slightly over same time period as last year. Electronic circulation might be cutting into physically being at library. Community gardens have produce available for anyone within community.
