BULK WATER:

All bulk water supplied to fill tank trucks, swimming pools, construction use, irrigation, or extinguish fires outside the utility's immediate service area from the water system through hydrants or other connections shall be metered. Utility personnel shall supervise the delivery of the water. Meters that are assigned to bulk customers for more than 7 days, the applicable service charge in Schedule Mg-1 will apply after the first 7 days. A deposit may be required for the temporary use of its equipment.

SPECIAL BILLING CHARGE:

Special Billing Charge - \$10.50

The Special Billing Charge shall be assessed to the requestor to cover administrative expense whenever an existing customer or the property owner requests a special billing outside of the normal utility billing. This charge may not be assessed to a new customer.

SPECIAL METER READING CHARGE: Special Meter Reading Charge - \$10.50

The Special Meter Reading Charge shall be assessed to the requestor whenever an existing customer or the property owner requests a special meter reading by utility personnel on a date other than the regularly scheduled meter reading. This charge may not be assessed if the customer or property owner provides the meter reading. This charge may not be assessed to a new customer.

Non-Sufficient Funds-NSF (returned check fee): \$25.00

A charge of 1.0% per month shall be applied to the total unpaid balance, including any unpaid payment charges. THIS CHARGE WILL BE ADDED TO BILLS NOT PAID WITHIN 20 DAYS FROM THE DATE OF ISSUANCE.

It is recommended to set your water heater thermostat at no higher than 125^o F in order to prevent severe burns and unnecessary energy consumption.
